Projects:

Lighting Update

- Price on higher lumens light: Rich will reach out to the company again for this.
- Cleveland Utilities charges for purchasing the poles for ourselves.
- Questions we still have: What would CU charge us for bulb changes as necessary if we kept all, 4, or 2? Can we get a price quote on this from a 3rd party? Our current usage is \$78 for all 27 which turns out to be \$2.88 per light pole. Once metered, should we expect this to be higher?
- Meeting with Cleveland Utilities was done via phone. They quoted us \$4,341.44 for all the poles. What would be the cost for keeping 4? 2? Each light would then need it's own meter. CU suggested it go to the nearest home.

Maintaining Entrance Sign:

Kent Berry kindly mulched in front the entrance sign this past weekend. We will still trim the bushes after today's meeting. If mulch is needed, we have already approved the purchase of 1 yard of mulch.

<u>Taxes</u>

The CPA completed our taxes. We owe \$0 to the IRS. It cost \$100 to have the taxes prepared. We then paid \$4.60 to have them mailed via certified mail. We have confirmation that they were received by the IRS on Monday, May 17. Kate paid for the postage and has completed a reimbursement form. Tiffany Fendley motioned to reimburse Kate in the amount of \$4.60 for the postage on the POA's taxes. Rich Kienlen second. All were in favor. Motion passed.

Community Yard/Garage Sale

Missy is thinking June 12th would be a great day for our community sale. She said we can post her phone # in the post informing the community of an upcoming sale and to keep an eye out for updates which she will then post. Thank you Missy Shaw for spearheading this! The total was \$494.84 however he gave us a \$100 courtesy discount. Christen Edmonds motioned to pay the attorney in the amount of \$394.84. Tiffany Fendley 2nd. All were in favor. Motion passed.
